

# Central Wyoming Groundwater Guardian Team

Minutes of Meeting  
November 29, 2018

Chairman Floyd Field called the meeting to order at 12:04 pm.

Members Present: Floyd Field, Bruce Pedersen, Margaret Teevens and Mike McDaniels with Regional Water.

Bruce made a motion to accept minutes of the September 27, 2018 meeting . Margaret seconded. Motion passed.

The well field is in winter mode, drawing all water from the well field and none coming from river water. Everything around the plant is getting cleaned and ready for next summer when once again the plant will use river water. We also discussed the need for notification of flushing flows in the spring and cut flows in the fall. Flushing flow notification is usually publicized in the spring. Regional will follow up on notifications.

It was noted that there is a need for new people on the board. We also discussed whether the Regional Water Board minutes are available on line. We thought this would be a good way for us to stay informed and work towards the same goals.

No updates were available on the HDR report.

The new backup generator has not been tested yet due to a couple of construction issues. It should be tested and online soon. The new outer drive tank is in service and the inside will be repainted this summer. The Wardwell tank is still pending. The new road from BarNunn to airport (the new off-ramp) is almost complete . The airport tank is in service. The Scada update bids are to be opened December 12<sup>th</sup>, 2018. The regional plant is currently producing 5-6 MGD. There will be a weather modification meeting in Cheyenne in December.

All 2003-2018 water testing data from Dempsey Acres has been collated into one spreadsheet.

The next meeting will be January 24<sup>th</sup>, 2018.
