Minutes of Meeting March 7, 2019

Chairman Floyd Field called the meeting to order at 12:02 pm.

Members Present: Floyd Field, Bruce Pedersen, Brian Schroeder with Regional Water, Margaret Teevens and Neil Kaiser with Casper College GIS.

Brian made a motion to accept minutes of the September 27, 2018 meeting . Bruce seconded. Motion passed.

Neil gave a presentation of his GIS degree project. He is working with the Natrona County Health Department on mapping all the septic systems for Dempsy Acres. The map output will show the water wells in relation to the septic systems. It will be a challenging project since the State of Wyoming information doesn't have their full mapping complete on water wells and not all water wells are registered. We can provide data to 2004 on septic. Neil would like more information on the 10 sites that we routinely sample. Brian will send him our information.

Copies are not available for the HDR source water protection plan although the reports is complete.

Spring flushing flows were discussed along with notification to the plant. Contact will be made with Lyle Mylar and we will ask to be placed on the notification list.

The back up generator is complete. The Wardwell tank roof repair is out for pre bid to be complete this spring/summer. The scada updates were awarded to HOA Associates from Lincoln Nebraska. They have started and anticipate a May 2020 completion.

Weather modification is not currently used by Regional. Snow pack forecasts and reservoir forecasts are all favorable. The plant is running at 5-6 MGD. There will be no river restoration in the well field area.

The next meeting will be January 18^h, 2019.
